Terms and Conditions -

1. This certificate is issued based on a written report from the Fire Officer, Municipal Corporation, Partur.
2. The validity of the said certificate is for 1 year and will continue from the date of issue of the certificate. It will be the responsibility of the applicant to get the said certificate renewed after 1 year from the date of issue.
3. It may be necessary to obtain a certificate from another authorized department in accordance with the safety certificate.
4. If any legal/administrative/private dispute arises regarding the certificate, the said certificate will be deemed to be cancelled.
5. The applicant shall be responsible for disposing of biological and other waste generated in the school as per government rules and it shall be mandatory for the applicant to follow the instructions given from time to time.
6. The Municipal Council Fire Officer may check/inspect the fire safety equipment at any time.
7. If any defect is found in the fire safety equipment, the certificate will be considered cancelled.



8. The terms and conditions of Standing Instruction 31 of the Commissioner and Director Municipal Council Administration, Worli, Mumbai as well as the rules and regulations in force from time to time of the Fire Service Advisor, Government of Maharashtra shall be binding on the applicant.
9. If renewal is not done within the prescribed period, the applicant will be charged double the amount of the certificate plus renewal fee.
10. All the terms and conditions of the Maharashtra Municipal Councils and Nagar Panchayats, Industrial Towns Act, 1965 shall be binding on the applicant.
11. It will be mandatory for the applicant to get a fire safety audit done through a government approved agent/institution before actually starting 'Dnyanlata Public School'.
